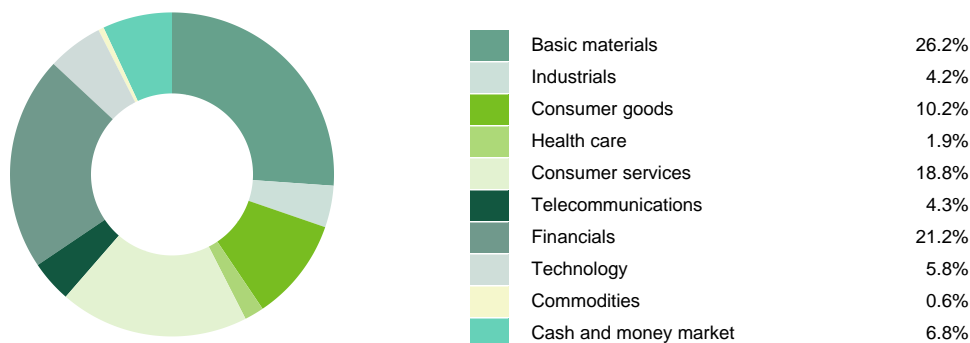

- Minimum 80% will be in SA equities, currently the portfolio excludes direct offshore investment.
