# PPS GLOBAL BALANCED FUND OF FUNDS



#### FUND DESCRIPTION

This is a multi-managed global balanced fund of funds that invests in foreign markets and is diversified across managers and strategies. The fund will typically have at least 60% invested in global equity markets. The fund will have a bias to managers that invest in developed markets, and who complement each other. The fund is suitable for investors with discretionary assets they wish to invest in foreign markets, or as part of a building block approach in a Regulation 28 portfolio, and who do not wish to make the foreign manager selection themselves.

The PPS Global Balanced Fund of Funds aims to consistently outperform its benchmark over consecutive 60-month periods. It is benchmarked against a global composite that is typical of the funds in its ASISA unit trust sector.







## FUND COMMENTARY

This FoF targets outperformance of a composite foreign equity:bond benchmark over rolling five years. Diversification is achieved on an asset class and manager level, with the FoF relying on specialist equity, property and fixed interest managers to outperform the benchmark.

Global equities tracked lower in rand terms in Q1 (-3.82%), with the rand's appreciation against the dollar contributing to weakness. Rand strength was primarily a function of US dollar weakness. Large cap tech stocks faced significant pressure, weighing on US equities. In contrast, European equities outperformed their US counterparts, particularly industrial stocks exposed to Europe's infrastructure and defence spending plans. Global Bonds were flat over the quarter (-0.3%), while listed property declined (-1.0%).

Against this backdrop, PPS Global Balanced outperformed both its 60/40 benchmark as well as its ASISA category average for the quarter, with its global bond exposure dampening the decline in global equities. Our house view remains neutral global equities and overweight bonds.

Over the five-year investment horizon of the FoF, SA equities (up 18.7% p.a.) have outperformed foreign equities (up 15.9% p.a.), while SA nominal bonds (up 11.7% p.a.) have outperformed SA inflation-linked bonds (up 9.3% p.a.), SA cash (up 6.2% p.a.) and SA inflation (averaging 4.8% p.a.).

Over the past five years (in rands), foreign equities (up 15.9% p.a.) have outperformed foreign property (up 7.0% p.a.) and foreign bonds (up -2.4% p.a.), with US equities having been a major driver of stock market returns. The FoF has underperformed its 60/40 benchmark over its most recent five-year investment horizon, due to recent underperformance from its small cap growth manager. We consider this temporary and maintain high conviction in the pedigree and mix managers. There were no material changes to the composition of the portfolio and underlying unit trust funds during the quarter.

The fund has adhered to its policy objective.

#### DISCLOSURES

Collective Investment Schemes in Securities (CIS) are generally medium-to long-term investments. Transaction Costs (TC) is a measure that can be used by investors and advisors to determine the costs incurred in buying and selling assets underlying the CIS. TC's are a necessary cost in administering the CIS and impact CIS's returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of CIS, the investment decisions of the investment manager and the TER.

Total Investment Charges (TIC) is a measure of total cost relating to the investment. TIC is the sum of the total expense ratio (TER) and the transaction cost (TC).

TER's and TC's are expressed as a percentage of the daily net asset value of the CIS calculated over the past one year and three-year period on an annualised basis. The TER and TC disclosed are estimates based on our best estimate of the underlying costs.

These performance figures are for lump sum investments with income distributions reinvested on the ex-dividend date. All PPS Multi-Managers performance figures and values are quoted after the deduction of costs and applicable taxes incurred within the Fund. Actual investment performance will differ based on the initial fees applicable, the actual investment date and the date of the reinvestment of income and dividend withholding tax. The reinvestment of income is calculated based on actual distributed amount and factors such as payment date and reinvestment date will be considered. Please note that performance over periods greater than one year is annualised. Annualised performance is relevant to the investment or the service offered by the manager.

Unit Trust prices are calculated on a Net Asset Value basis, which is the total market value of all assets in the portfolio including any income accruals and less any deductible expenses from the Fund divided by the number of units in issue. Transactions must be received by the Management Company (MANCO) by 2pm to receive the net asset value price for that day. Transaction requests received after this cut off time will only be processed on the next business day, and will receive the price of that day. Linked Investment Service Providers (LISP), specify their own transaction timelines and may take up to five business days to process. Portfolio valuations occur at 3 p.m. on business days, except the last business day of the month, when it will be 5pm. Prices are published daily and are available in the daily newspapers.

A schedule of fees, charges and maximum commissions are available on request. This fund does not charge performance fees.

The manager may close the portfolio to new investors to ensure the portfolio is managed according to its mandate.
